## Web Notice

- In pursuance of Notification No.3/2022 and addendums issued thereon for recruitment to the post of Staff Nurses, details containing total points/marks obtained by applicants (normalised marks in CBT plus weightage points for contract/outsourced service in state government hospitals/ institutions/ programmes) along with other details of applicants were released on 18.12.2023. Applicants were requested to go through their details and submit objections/representation, if any, online after logging into their accounts on the MHSRB website.
- The objections filed by the applicants have been examined and disposed as per rules. After due consideration of the objections from the applicants, 'Provisional Merit List' is prepared and is hereby issued.
- 3. Based on 'Provisional Merit List,' it is hereby decided to do certificate verification of the applicants in the ratio of 1:1.25. Certificate verification will take place from 30.12.2023 to 6.1.2024 at Excise Academy for State of Telangana (East), 120/P, St.Michael's Colony, Abhyudaya Nagar, Abhyudaya Nagar Colony, Bandlaguda Jagir, Hyderabad 500086. The details of the applicants who are called for certificate verification along with the date and session on which they are called for certificate verification is appended herewith.
- 4. The applicants should bring the following **original certificates/documents** along with **two sets of photocopies** of each of the certificates/documents for verification:
  - i) PDF of application form downloaded from MHSRB website
  - ii) Aadhaar Card
  - iii) Proof of Date of Birth (SSC or its equivalent certificate)
  - iv) Community Certificate (SC/ST/BC certificate) issued by Telangana State Government (as applicable).
  - v) Latest Non-Creamy Layer Certificate in form VII-B issued by competent authority (as prescribed in Govt.Memo.No.3009/BCW/OP/2009 BC Welfare (OP) Dept Dated 18.12.2015 read with G.O.Ms.No.20 BC Welfare (OP) Dept Dated 31.10.2017) for BC community applicants who claim to be in Non-Creamy Layer category. The BC applicants who do not produce latest Non-Creamy layer certificate will be considered under OC.
  - vi) Latest Income & Assets Certificate for applicants claiming **EWS reservation** issued by the Competent Authority of Telangana Government.
  - vii) Sports certificate for applicants claiming reservation under sports category issued by the Competent Authority of Telangana Government.
  - viii) SADAREM Certificate for applicants claiming PH reservation

- ix) The following certificates in case of age relaxation claimed (as applicable):
  - (a) Service certificate in case of regular government employees
  - (b) Service certificate as Ex-servicemen
  - (c) Service certificate as NCC instructor
- x) For applicants claiming local status, School Study Certificate from I to VII Class if studied in School; OR Residence Certificate during the corresponding period issued by the Tahsildar (Govt. of Telangana) in case of Private study.
- xi) GNM or B.Sc (Nursing) certificate
- xii) Telangana Nursing Council Registration Certificate
- xiii) One passport size photograph of the applicant

# 5. Applicants are informed that failure to attend certificate verification or failure to bring any of the above original certificates in the proforma as prescribed by the government will lead to cancellation of their candidature.

6. It is further informed that the list displayed herewith is not a selection list. Number of persons called for certificate verification is more than the number of posts notified. Mere inclusion of name of the applicants in the list for certificate verification does not confer any right for appointment.
